# RLBC Social Justice Team Vision Statement

October 2018



## **Purpose**

At a 2016 leadership meeting, the Missions Division adopted a model for missions that includes social justice. The Social Justice Team (SJT) was subsequently formed in October 2017 to explore ways that RLBC can engage in the social justice component of this model.

In the spring of 2018, the SJT was tasked by the Missions Division to begin a broader dialogue with the congregation about what social justice means at RLBC, what issues we should address based on that common understanding, and what



organizations we should partner with in order to educate ourselves and access the resources we need to be effective in the social justice work that God is calling us to.

This vision statement describes the initiatives that the SJT will focus on initially. These initiatives were selected based on the results of listening sessions conducted during August and September 2018, a confirmation survey that was made available to the entire congregation, and numerous one-on-one conversations that SJT members had with individual members of the congregation

## **Listening to the Congregation**

The SJT conducted listening sessions (Justice Jams) in August and September in an effort to answer the following question:

What does social justice mean at RLBC?

Specifically, what is our "sweet spot"? What is the intersection of the social justice needs in our community, our gifts/talents/resources, and our passions?



#### **Timeline**

Nine listening sessions were conducted as follows:

- 1. Aug 20 home of Margaret Darden
- 2. Aug 25 home of Rosa & Joey Belgard
- 3. Aug 26 home of Christine & Scott Gonzalez
- 4. Sep 8 home of David Doom
- 5. Sep 13 home of Barbara Gunnin
- 6. Sep 22 home of Sandy & Doug Washington
- 7 9. Sep 23 RLBC two adult sessions and one youth session

#### **Facilitation Team**

For each listening session, there were three roles:

- **Host** Provided the meeting space and food/beverages. Welcomed the participants and set the tone of the conversation.
- **Facilitator** Kept the conversation focused on purpose by leading activities and asking prompting questions.
- Secretary Kept a written record of the conversation for later debrief by the SJT.

### **Listening Session Takeaways**

83 Royal Laners participated in the listening sessions.

Each listening session was comprised of three major components:

- 1. A spiritual formation exercise to identify each participant's primal value.
- 2. Small group exercises designed to help each participant:
  - a. Uncover the source of his/her primal value
  - b. Make a connection between primal values and social justice points-of-view
  - c. Describe an individual vision of social justice at RLBC rooted in each participant's primal value.
- 3. Large group debriefs of each exercise described above.

After each listening session, the secretary summarized the broad justice themes revealed during the dialogue.

## **Confirmation of Listening Session Takeaways**

Once the last listening sessions were complete, the SJT compiled a list of themes that were common across sessions. They were:

- Criminal Justice Reform
- Education Reform
- Healthcare
- Homelessness
- Immigration Reform
- LGBTQ+ Equality
- Moral Economy
- Racial Justice
- Voter Engagement

These themes were used to build a confirmation survey that was made available to the entire congregation from Sep 24 – Oct 5.

## **Confirmation Survey Results**

For the purpose of this survey, justice work was defined as "Identifying systemic problems that affect our community; engaging with those affected, public officials, and decision makers to impact policy changes."

Given that definition, respondents were asked to indicate their level of agreement with the following statement:

I believe that RLBC should undertake justice work as defined above.

Responses to this question were as follows:

In accordance with respondents' passion for the themes previously listed, they were prompted to rank each theme as a potential RLBC social justice initiative. Those rankings are shown in the following table.

Survey responses were assigned a weighted score based on overall rankings. In other words, each respondent's highest priority was assigned a weight of 9, second priority a weight of 8, etc. Each person's lowest priority was assigned a weight of 1. The score for each initiative is the sum of these weighted scores.


Finally, respondents were given the opportunity to provide free-form feedback in response to the following questions:

- Please indicate any justice issues that should be added to the list above and indicate your priority for each.
- What else would you like to share with the Justice Team?

These responses can be found in the appendix to this document.

Between the Justice Jams and the confirmation survey, 101 Royal Laners have engaged in this process:

- 43 people attended a Justice Jam but did not complete the survey.
- 18 people completed the survey but did not attend a Justice Jam.
- 40 people did both.



## **Initial RLBC Social Justice Team Focus**

Based on the findings from our listening sessions, the subsequent confirmation survey results, and the numerous one-on-one conversations that SJT members had with Royal Laners, the SJT proposes to engage in the following initiatives grounded in human dignity.

Our three initial, co-equal focus areas will be:

- Racial Justice, for people of color in our community.
- Immigration Reform, particularly for Muslim and Central & South American immigrants.
- Healthcare Access, for people who lack adequate and affordable healthcare.


Note: While the initiatives described in this document comprise our initial focus, it is assumed that they will change over time as needs in the community change and passions in the

congregation evolve. The SJT will undertake periodic listening sessions to ascertain the will and passion of the congregation as time progresses.

There will also be occasions when events unfolding in the world demand a rapid response that may fall outside the initiatives listed herein. As and when that occurs, the SJT will make a response recommendation to the missions division and the deacon board, ask for a timely decision that is tied to the urgency of the situation, and respond in accordance with their counsel.

#### Where Are We Now?

The following image depicts the cycle that the SJT is following as we continue to discern God's calling for RLBC in the public arena.

# **Strategic Partnership**

Throughout the initial phase of our Justice Team work, we partnered with Faith in Texas (FiTX), a multi-racial, multi-faith organization that develops civic leadership in faith communities for economic and racial justice. FiTX has been an invaluable resource to us as we educated ourselves about the justice issues facing our community. FiTX also provided impactful and well-designed training opportunities as we prepared to lead the social justice conversation at RLBC and to organize ourselves around the initiatives that Royal Laners indicated they care about the most.

Given the relationship we have established with FiTX and the social justice passions of the congregation, we will be recommending to the Congregational Affiliations Committee that this partnership be officially sanctioned by the church.

Formally aligning with FiTX requires an annual investment of .5% (1/2 of 1%) of our budget. For FY2019, that would amount to approximately \$3,500. This would appear as a line item in the Missions budget.

- I appreciate RLBC's efforts for Social Justice. This should become a much larger part of what we do.
- I know the committee worked and I appreciate it, as well as the way the meeting happened when I attended the one I did. However, justice work is important, but I want to come to church and worship God, enjoy fellowship of my church family, be encouraged and yes, be involved in social justice, but we are a church, not a club or "social" network. We must be involved in social ministries but we are monotheistic, and God needs to be first, not a social action, which is an outgrowth of a healthy relationship with God.
- I thought the Jam sessions were well organized and executed. Your intentional standardization of the discussion framework across sessions enhanced the validity and reliability of your results - i.e., you can have a higher level of confidence that you have tapped the true values and beliefs of the broader congregation regarding social justice. The thought exercise using the "boxes in the boat" metaphor was brilliant! I still find myself thinking about it and what it means for me, my own values, and what my role should be at RLBC related to social justice. I would encourage you now to be at peace about this process and to let go of any anxiety that you might be feeling at this time or after the congregational vote in October. The vote will (likely) not be unanimous, and that is to be expected. We are Baptists, after all. There will be a few dissenters who say we are being "too political" or that we are moving "to far ahead of where our congregation is and we will lose members." So be it. These are familiar lines that I have heard at Royal Lane over the past 25 years whenever we decided (thoughtfully and intentionally) as a congregation to do something bold and important. When Mahatma Gandhi was asked "what is the most important quality in spirituality"? He said "the most important thing is to be brave. Don't be a coward. A coward is incapable of exhibiting love; it is the prerogative of the brave." ~ Mahatma Gandhi (1869-10-02 1948-01-30 age:78) Royal Lane must be a courageous church that always acts out of love. "There are times when you have to obey a call which is the highest of all, i.e. the voice of conscience even though such obedience may cost many a bitter tear and even more, separation from friends, from family, from the state, to which you may belong, from all that you have held as dear as life itself. For this obedience is the law of our being." ~ Mahatma Gandhi (1869-10-02 1948-01-30 age:78)
